Collection of your Personal Information

Information about your computer hardware and software may be automatically collected by LCCB. This information can include, but is not limited to: your IP address, HTTP header, system date, full request, status, content length, method, URI, URI Query String, protocol, browser type, domain names, access times, location at the time of access, and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the LCCB website.

Use of your Personal Information

All such third parties are prohibited from using your personal information except to provide these services to LCCB, and they are required to maintain the confidentiality of your information.

LCCB will disclose your personal information, without notice, where permitted or required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on LCCB or the site; (b) protect and defend the rights or property of LCCB; and, (c) act under exigent circumstances to protect the personal safety of users of LCCB, or the public.

Use of Cookies

The LCCB Website may use "cookies" to collect data and help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web server. Cookies cannot be used to run programs, are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize LCCB pages, or register with LCCB site or services, a cookie helps LCCB to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
